

# Cookie policy

## 1. Introduction

Our website [www.studentdepot.pl](http://www.studentdepot.pl) (the "**website**") uses cookies and other related technologies (for convenience, all technologies are referred to as "**cookies**"). In this cookie policy (the "**policy**") we inform you about the use of cookies on our website.

## 2. What are cookies?

Cookies are small text files sent by websites when you browse them, which are stored by the browser on your device. The information contained in cookies may be returned to our servers or to the servers of relevant third parties during your next visit.

## 3. Cookies

On the website, we use essential cookies, so-called technical cookies, and additional cookies: functional, analytical, advertising, and other cookies that monitor website traffic.

### 3.1 Necessary cookies

Necessary cookies are cookies that allow the website to function and be used properly. They allow you to take the action you request, such as changing your privacy settings, logging in or filling out a form. Without these files, it is not possible to browse the website. For this reason, we may place these cookies without your consent.

### 3.2 Functional cookies

Some cookies provide additional functionality to the website. By placing functional cookies, we make it easier for you to visit our website. In this way, you do not have to enter the same information repeatedly when visiting our website, and the search filters you apply or the location selection you make will not change. The use of such cookies requires your consent.

### 3.3 Analytical cookies

### 3.4 Advertising cookies

We use advertising cookies on this website to determine your preferences and give us insight into the results of advertising campaigns. This happens based on profiles that we create based on your behaviour on the website. With these cookies you are, as a visitor to the website, associated with a unique ID. These cookies will take into account your behaviour on our website and analyse your interests in order to display personalized ads for our services on third-party websites. Some of the advertising cookies may analyse your behaviour outside the website to analyse general statistical and demographic data. The use of such cookies requires your consent.

### 5. Consent

When you visit our website for the first time, we will show you a cookie banner with an explanation about installing cookies on your device. By clicking the "Accept all" button, you consent to our use of all types of cookies as indicated in this policy. It is also possible to limit our use of cookies by selecting the specific types of cookies that will be installed on your end device and agreeing to them using the "Accept selected" button. In case you do not consent to the installation of any cookies on your device, you should click the button: "Reject all". Note, however, that the last two options do not apply to essential cookies, which can be used without your consent.

### 6. Enabling, disabling and deleting cookies

The use of cookies can be disabled. You can also use your web browser to automatically or manually delete cookies. You can also decide which cookies are not to be placed on your device by selecting the appropriate fields in the panel that will appear on the website with the start of its use as described in section 5 above. However, this does not apply to essential cookies, the installation of which is necessary for the proper functioning of the website. Another option is to change your browser settings so that you receive a message each time a cookie is placed. For more information on these options, see the instructions in your browser's help section.
