

Regulations

1. The Organizer of the "Visit Open'er with Student Depot" competition is Student Depot Ltd., address: Al. Jana Chrystiana Szucha 6, 00-582 Warsaw. The competition aims to promote student cultural events and Organizer services.
2. The contest participant is every adult person who meets the following conditions:
 - 2.1 is a high school graduate or student
 - 2.2 has an account on Facebook
 - 2.3. and performs the competition task at the given date and in the correct manner.The participant may submit one application to the competition.
3. The competition task consists of:
 - 3.1. making available the appointed competition graphics on the Participant's wall in public mode
 - 3.2. the answer to the question of which star Opener wants to see from close up
 - 3.3. and the answer why Student Depot is the best place to live during your studies.
4. The prize in the competition is a pack containing two weekend tickets for the Opener festival. Tickets entitle to the following benefits:
admission to the festival area on 6.07 / 7.07.2018
stay (place) at the campsite from 6/06/2018 10:00 to 8/07/2012 14:00
5. The competition task should be completed from 4.06.2018 to 1.07.2018 by the end of the day. 2.07.2018 to 12.00 the information about the winner will be published on the Student Depot fanpage. In addition, the winner will be informed about the prize in a private message via Facebook, and if the winner publishes a phone number, the information will also be provided by phone.
6. The winner will be the person who obtains the most Facebook reactions under his or her competitive entry (eg likes). In the case of posts with the same number of reactions, the final winner will be selected by the competition jury composed of: Jolanta Bubel (chairwoman of the commission), Justyna Miszczuk (member of the commission). The criteria for selecting the winner are: the attractiveness and linguistic correctness of the answers given to the competition question.
7. The prize will be sent via e-mail to the e-mail address indicated by the winner.
8. Complaints should be submitted in writing to the organizer's address from 3 July to 10 July 2018. The complaint should contain personal details, such as name, surname, address, e-mail address, telephone number, and describe the reason for the complaint. Complaints will be considered within 7 days of submitting by the competition committee.
9. The participant, by accepting these regulations, confirms that during participation in the competition he did not infringe copyright and related rights and other rights.
10. The winner of the competition is subject to the detailed rules indicated by the organizer of the Open'er event. The organizer of the competition is not responsible for the activities of the organizer of the Open'er event and for random and personal situations that can affect the use of the prize by the winner.
11. The winner of the competition is required to provide photographic documentation in the form of a minimum of 5 photos of his/ her authorship from the Event with a description that the organizer has the right to use freely for promotional purposes. The pictures will contain the Winner image. The photos are to have the format and resolution of min. 300DPI, allowing to use them for printing.
12. In matters not covered by these regulations, the provisions of the Civil Code shall apply.
