- 1. The Terms and Conditions apply to all persons residing at Student Depot at ul. Robotnicza 96 in Wrocław, who are using the offer through a dedicated form available at www.studentdepot.pl and participating in World Masters Squash Championships held by Hasta La Vista Sports Center.
- 2. The form will remain accessible until 31 May 2022. Requests made at a later time will be accepted depending on availability.
- 3. These Terms and Conditions apply to reservations and stays in Student Depot made between 9 August 2022–28 August 2022.
- 4. Guest attendance services are provided by our administration on weekdays between 9AM–6PM, tel. +48 794 416 332. Round-the-clock security staff is available at +48 693 266 305
- 5. You will be charged for your stay in the following manner:
- 5.1. 50% of the amount is payable within 7 days after making the reservation into the bank account number indicated in the confirmation sent by e-mail.
- 5.2. The remaining 50% of the amount is payable not later than 14 days before arriving at Student Depot Wrocław.
- 5.3. Cancellation can be made free of charge until 30 May 2021. To make a cancellation and have the deposit refunded, please contact us by using the e-mail address provided in the reservation e-mail message.
- 5.4. When Guest makes a cancellation while staying at Student Depot Wrocław, the deposit is not refunded.
- 6. When Guest makes a reservation but fails to appear on the day of the reservation by 6PM and fails to give notice about the delay, Student Depot Wrocław reserves the right to release the room without informing Guest thereof. In such case, the already paid 50% of the reservation fee is forfeited to Student Depot Wrocław.
- 7. The check-in procedure requires Guest to provide an ID or passport.
- 8. Rooms in Student Depot Wrocław are leased for 24-hour hotel days.
- 9. Check-in time is 3PM on the day of arrival. Check-out time is 11AM on the following day.
